Applications for this scheme closed **31 October 2022**, this deadline is given as the Government says no more grants can be paid after the end of November 2022. In early November, if any discretionary money is left, we will process the last of the grants and decided how we allocate any remaining money.

Automatic awards and how it has been paid

You were eligible for a payment if you met any of the following criteria:

 You live in a property in council tax bands A to D (or E in disabled band reduction scheme) and you are in receipt of Local Council Tax Support you will have received £150 Council Tax rebate payment plus an additional £20 discretionary payment

People who were eligible and pay their Council Tax by Direct Debit will have received a payment by 25 July 2022.

People who don't pay their Council Tax by Direct Debit, who were eligible and who completed an application for the £150 application Rebate Grant, will have received a payment for the discretionary £20 into their bank account, by 25 July 2022.

Those eligible residents, who aren't on Direct Debit and who did not complete an application or whose bank details were not successfully verified, will have had the £150 Rebate Grant and £20 discretionary payment applied to their council tax account by 22 July 2022.

Following the Discretionary award being applied, if your council tax account is now in credit, please complete a refund request form to apply for a refund:

- Fenland refund request
- East cambridgeshire refund request
- You live in a property in council tax bands E to H and you are in receipt of Local Council Tax Support you will receive a £170 energy rebate payment.

Direct debit payers you will have received a payment by 25 July 2022.

 You live in a property in council tax bands E to H and are exempt from council tax under Class U (Severely mentally impaired) you will receive a £150 energy rebate payment.

 You live in a property in council tax bands F to H and you are a liable council tax payer who qualifies for the disabled band reduction you will receive a £150 energy rebate payment. PLEASE NOTE: anyone living in a band E property who qualifies for the disabled band reduction would've received a payment under the main scheme.

Non-direct debit payers bands E to H who meet the criteria above

We wrote to you inviting you to complete a secure online form with your bank details so that we can make a payment to you, alternatively if you do not want to complete a form the payment will be applied to your council tax account.

The deadline to complete the form was 31 July 2022

Please note that where bank account details are supplied we are required to carry out mandatory pre-payment checks using a secure application supplied by the Cabinet Office.

If your bank account details passed the mandatory pre-payment checks you should have received a payment into your bank account on our around 10 August 2022

If your bank details did not pass the above pre-payment checks the payment will have been applied to your Council Tax account. If your account was subsequently in credit, we will have tried to contact you to tell you how you can apply for a refund.
